This funding is allocated to the Higher Education Emergency Relief Fund II (HEERF II) by the Coronavirus Response and Relief Supplemental Appropriations Act (CRRSAA), which was signed into law by President Donald J. Trump on Dec. 27, 2020.

PCI Health Training Center agrees to promptly make available emergency financial aid grants from the advanced funds, directly to students for their expenses related to the disruption of campus operations due to coronavirus, such as food, housing, course materials, technology, health care, and child care expenses.

PCI Health Training Center designates students who were active as of March 31, 2021 and eligible to apply for financial aid are eligible for the funding.

- 2. The students with zero EFC will be awarded \$2550.00. EFC Ranges 1-1000 = \$2400.00, EFC Ranges 1001-2000 = \$2200.00, EFC Ranges 2001-3000 = \$2000.00, EFC Ranges 3001-5712 = \$1800.00, EFC Ranges 5712-9999 = \$1500.00.
- 3. All funding will go to the student. It will be up to the student to pay any tuition balances due.
- 4. The funding will be issued by a debit card.
- 5. The debit cards will be mailed to the Institution by Prepaid Technologies and will need to be activated by the student with their social security number and date of birth. A Pin number will be required to be set up at the time of activation.

ARP: American Rescue Plan (HEERF III)

The Higher Education Emergency Relief Fund III (HEERF III) is authorized by the American Rescue Plan (ARP), Public Law 117-2, signed into law on March 11, 2021, providing \$39.6 billion in support to institutions of higher education to serve students and ensure learning continues during the COVID-19 pandemic.

ARP funds are in addition to funds authorized by the Coronavirus Response and Relief Supplemental Appropriations Act, 2021 (CRRSAA), Public Law 116-260 and the Coronavirus Aid, Recovery, and Economic Security (CARES) Act, Public Law 116-136.
